## High Performance Summer Clinic

**High Performance Tennis Camp** is a program designed for our junior players looking to improve their tournament play. Each week will consist of an area of improvement, and each day players will work on using our award winning coaches to make THEIR game better! Players will learn through fed ball, live ball, and point play progressions. Each class will consist of match play and fitness. Players will work with coaches in determining their summer tournament schedule. Admission to the program is based on student's tournament and high school tennis results. Camp will primarily be held outside, there will be instances that we will play indoors on our air-conditioned courts.

### Additional Information, Rules and Regulations:

**Attire & Supplies:** Most play will be outdoors. Juniors should bring water, sunscreen, hat, towel & chair (optional).

**\*July 4th Holiday:** There are no classes on Tuesday, July 4th, 2023. This 4-day week is automatically pro-rated.

**Behavior:** Juniors behaving in a disruptive manner are subject to removal without a refund.

**Pre-registration:** Pre-registration is imperative to the success of the program particularly with limited space. Drop-ins will only be accepted if notified 24 hours in advance and will only be accepted if we have spaces available. Drop-in rates have been established for this sole purpose.

**Delinquent Payments or Return Items:** Will be sent to an outside collection agency.

**Drop off & Pick Up:** Juniors must check in no later than 10 minutes prior to class beginning and must be picked up promptly at the end of class.

**Cancellations:** Based on the limited number of participants we are able to host in each class, refunds will not be provided for no shows or less than 24-hour cancellations.

\*\*\*Please note that we will follow all Federal, State and Local CDC guidelines for the safety of our members and staff. Our staff will continue to monitor the CDC requirements and recommendations and this may affect the maximum number of participants in our classes.\*\*\*

**Limited Program Membership (LPM):** In order to participate in any Aspen Hill Club Junior Tennis Program, one must be a full tennis member of the Club or purchase a Limited Program Membership. The fee is \$175 for an individual and \$150 for each additional sibling for High Performance Tennis Camper who participate in Junior Advancement, Future Stars and World Class Elite programs in the fall, winter & spring. The Limited Program Membership agreement must be completed with payment prior to the start of the program. In order to take private or group lessons, one must be a member of the Club or a LPM participating in the Junior Program.
